Is the head of a Treaty group or a First Nation organization or association with which the BC Assembly of First Nations has entered into a written protocol that allows for invitations to be extended to such persons to attend and be permitted to speak at Assemblies on specific issues, as authorized by the protocol;
 - c. Is a member of the BCAFN Board of Directors but is no longer a Chief pursuant to the Society's Constitution and Bylaws and Policy and Procedures Manual; or
 - d. Is a Committee Representative pursuant to the Society's Constitution and Bylaws and Policy and Procedures Manual.
- ** Any person who is ineligible to register as a Chief, Proxy Holder, Participatory Representative, Elder or Student Observer may apply to register as an Observer.

Registration Deadline: Wednesday, August 12th, 2020
